1. Variance Application for 28 East Shore Drive, Block 402 Lot 14 Discussion

Chairman D. Hansen stated that a variance application was received for 28 East Shore Drive. He stated that the well and septic are not the required 100' from each other. His proposed well would be 70' from his proposed septic system and his well would also be 82' from the septic system located across the street. The State of New Jersey has issued a well permit for the lot with a requirement that 80 feet of casing be provided rather than 50 feet of casing to make up for the extra 30 feet.

Chairman D. Hansen stated that there is a pending application before the Zoning Board for variances required in order to construct a single family house. He stated that the Board of Health will not have a public hearing on the variance until after the Zoning Board approves having the single family dwelling built.

Chairman D. Hansen stated that the next Zoning Board meeting is October 5th so if at that time the Zoning Board approves the variance, then the Board of Health will have a public hearing on October 17th. If the Zoning Board does not approve the variance at that meeting then the Board of Health will cancel its meeting scheduled for October 17th and the next meeting will be on November 21st.
