Bailey spoke with the tenant and asked to keep food garbage in covered container inside the house until garbage pickup day if necessary and to keep empty plastic bottles in a separate bin for recycling.

#### Complaint Investigation at A.C. Moore on 3/19/2020

Health Inspector C. Whitehead stated that someone called in to report that the Management at A.C. Moore is doing nothing to protect employee's and cleaning the store properly. They requested that something be done and asked to follow up on inspecting. She stated that Health Inspector T. Bailey spoke with the manager on the phone and emphasized the need to keep hand soap and running hot and cold water available in restroom for the employees. The manager stated that AC Moore has running water, soap and a hand dryer available for employees. The store will be closing permanently in a week.

#### Complaint Investigation at Villa Capri on 4/23/2020

Health Inspector C. Whitehead stated that the complainant called in to report that Villa Capri is not complying with the Governor's ruling to wear face masks and have a barrier up. Health Inspector C. Whitehead spoke with the owner, Mike Collins. He stated that he was unaware of the recent requirement to have all employees & customers wear face coverings. He was referred to Executive Order 125 and advised him to become aware of all requirements there.

# <u>Safe Water Complaint Investigation at Dairy Queen & Windy Acres Campground on 5/10/2020</u>

Health Inspector C. Whitehead stated that this was correspondence with Marcia Chirico. She had received the State's list of seasonal PNC systems that she had to follow up with. She needed to check with Dairy Queen & Windy Acres Campground to verify that they were not open due to COVID19 restrictions and that they notified the State that they were not opening on schedule otherwise violation would have gotten triggered if they did not sample for the month of April. They both complied with what they needed to do as far as notifying the State.

#### Complaint Investigation at 2 Peragino Road on 5/11/2020

Health Inspector C. Whitehead stated that this was a reporting that someone has illegally dumped construction debris and equipment in a wetlands area. She stated that Candace Morgan inspected and found various household debris strewn throughout the yard including but not limited to: plastic buckets, aluminum ladders, cut fire wood, blue tarp, 4 parked cars with license plates, riding lawn mower, push mower, plow blade, approx. 10 2x4 pine boards, chain link dog enclosure. There was no tall vegetation and most items appear to have been stored there for 6 months or less. The items observed to not appear to be waste. Observed additional gravel/dirt driveway that extended up the hill at the end of the paved street. This additional driveway was barricaded with a steel cattle gate that was pad locked and chained and posted with multiple signs reading "no trespassing", "keep out". Property was in-accessible beyond the gate. Called complainant's number to obtain additional information but complainant said he received an anonymous email and unfortunately he has no further information available. No further action required at this time.

#### Noise Complaint at Newton Toyota on 5/19/2020

Health Inspector C. Whitehead stated that the complainant stated that there was pumping of waste water early in the morning and that they were mowing the lawn early in the morning on Sunday. M. Theese contacted the manager of Newton Toyota. She advised that a noise complaint was received and that Hampton has a noise ordinance to schedule the pumping of waste water and to do landscaping later in the day.

#### Safe Water Complaint Investigation at SCARC on 5/19/2020

Health Inspector C. Whitehead stated that SCARC is on the EPA ETT list for failure to provide test results for Lead and Copper that quarter. It was a notice to them to make sure they do their testing soon.

#### Noise Complaint at Newton Vet on 5/19/2020

Health Inspector C. Whitehead stated that this was an additional complaint made by the same person for Toyota stating that their dumpster trash pickup was being done at 6:30am. Maureen Theese spoke with Newton Vet and asked that they have their garbage hauler pick up garbage later in the day.

#### Complaint Investigation at Carriage Acres on 8/10/2020

Health Inspector C. Whitehead stated that this complaint was from a resident who said she had no hot water, and mouse feces in her trailer. Elaine Martinez from the Health Department was in contact with management at Carriage Acres to get this addressed.

#### Complaint Investigation at Hampton Park on 8/11/2020-8/21/2020

Chairman D. Hansen stated that there are issues with the well water testing again. He stated that the new well was drilled a couple years ago but has failed for e-coli or total coliform or both at the same time. He stated that the township may need to look into a treatment system to add on such as a blue light.

#### **Storage Tank Spill at Newton Audi on 8/24/2020**

Secretary V. Ingles stated that the incident description stated that a waste oil tank was leaking outside. There were "rags and speedy dry" around the tank but the caller said it didn't look like it was working. It stated that there were 5 gallons of oil waste estimated. The NJDEP is assigned to the case.
