Sussex County Health Department Report for February 2021:

Chairman D. Hansen requested that the Safe Water Complaint Investigation on various dates at Kia, and the Complaint Investigation on 2/26/2021 at Carriage Acres Mobile Home Park be removed from the Consent Agenda for further consideration.

Sussex County Health Department Report for March 2021:

Chairman D. Hansen and N. Walker requested that the Complaint Investigation on 3/9/2021 at McDonald's and the Complaint Investigation on 3/10/2021 at Hampton Township Municipal Building be removed from the Consent Agenda for further consideration.

A MOTION was made by Vice Chairman E. Hayes and seconded by N. Walker, with all members in favor, to approve the Consent Agenda as listed above with the items referenced removed for further consideration.

CONSENT AGENDA ITEMS TO BE DISCUSSED SEPARATELY

Safe Water Complaint on Various Dates at Kia

Health Inspector C. Whitehead stated that this was carryover from January that was discussed at our last meeting. The Kia dealership was previously known as Newton Kia/Kia of Sussex but has changed names and is now called Major Kia. The owner of the dealership also changed hands and opened remotely. There were no water results in for the 2nd, 3rd and 4th quarter of 2020, which the Health Department was told that the building was vacant during that time.

Complaint Investigation on 2/26/2021 at Carriage Acres Mobile Home Park

Health Inspector C. Whitehead stated that a complaint was made that the septic system has been malfunctioning there for a long time. That is has been seeping above ground and has had an odor there. Health Inspector Anita DeMatteo inspected and noted that the area was saturated with puddles, however snow was melting. There was an area where soil was eroded possibly from pump discharge. The complainant was referred to contact the NJDEP. The DEP has issued a notice of violation to Carriage Acres for having a malfunctioning septic system and instructed them to correct it.

Period from 03/01/2021 to 03/31/2021

Complaint Investigation on 3/9/2021 at McDonald's

Health Inspector C. Whitehead stated that a complaint came in that a woman had purchased food at the McDonalds the day prior to her complaint. Her kids didn't drink their Oreo Milkshakes so she put them in the freezer. The next day they drank their milkshakes but said one was heavy, there was a dead mouse in it. She said they contacted McDonalds but they were of no help. C. Whitehead went to McDonalds, spoke with manager J. Perez and other employees about the complaint as they were not aware of it. She looked for rodent droppings in the milkshake machine and the entire facility and found none. She also checked the log book from the exterminator who visits monthly and saw no notes of rodent activity. The milkshake machine was clean inside, as was the area around it. The clear cups for the milkshakes are stored properly. No further action needed.

Complaint Investigation on 3/10/2021 at Hampton Township Municipal

Secretary V. Ingles stated that this was correspondence relating to the pavilion. She stated that the water tests have passed for the pavilion. The restrooms are available for immediate use for people renting the pavilion and there is a plan to hire a professional cleaning company to clean the inside of the pavilion kitchen before use. She stated that KLL has shown an interest in using the pavilion to prepare hot foods in to sell.

A MOTION was made by T. Cassidy and seconded by Vice Chairman E. Hayes, with all members in favor, to approve the items removed from the Consent Agenda.

OLD BUSINESS

1. Update: Newton Vet 2021 Kennel License: V. Ingles

Secretary V. Ingles stated that the Newton Vet has obtained their 2021 Kennel License. She stated that everyone is in compliance at this point.

NEW BUSINESS

1. NJ DEP Suspected Hazardous Substance Discharge Notification 4 Grove Road

Chairman D. Hansen stated that a notification report was sent from the NJ DEP for suspected hazardous substance discharge from 4 Grove Road. He stated that it looked like an old oil tank was removed and it must have leaked during the removal. The cleanup is pending.

Chairman D. Hansen asked if anyone else had any new business to report.

T. Berkheiser stated that the park pavilion seemed to have been a stagnant issue but now seems to be moving forward. He felt that no further action would be needed at this point to contact professionals about their opinion on the park well. He stated that there is the COVID related relief money that could be used for water related purposes.

Chairman D. Hansen stated that the Township Engineer looked at the running a line from the Department of Public Works to the pavilion but that it wouldn't been enough water or pressure. He stated that the town is aware of the COVID relief money and has been considering how to use the money once it's received. The plumbing in the pavilion is about 40 years old and they water heater is only about to hold 20 gallons of water. He stated that they have been discussing whether to upgrade the system or replace the entire pavilion itself.

Chairman D. Hansen stated that the next Board of Health meeting would be in July and should be in person at the Municipal Building.

Chairman D. Hansen stated that the NJ Local Boards of Health Association (NJLBHA) sent a letter back to the Board of Health Members thanking them for rejoining the NJLBHA and enclosed their 2021 membership cards.
