CONSENT AGENDA ITEMS TO BE DISCUSSED SEPARATELY

Re-inspections on 1/23/2017 at Boomer's Place

Health Inspector C. Whitehead stated that everything is in compliance at Boomer's Place. Their water will be tested monthly for a minimum of a 12 month period. They have had one good water test so far and are back to using their well water instead of bottled.

Complaint Investigation on 1/26/2017 at 279 Lakeview Drive

Health Inspector C. Whitehead stated that this complaint was from an annomyous resident that there was recycling/cardboard/trash all spread over the front yard and that it has

been that way for the past few weeks. She also noted that the complaint included bulky items on the front yard as well as cars on blocks but that was referred to the zoning inspector.

C. Whitehead stated that she went to the property and did not observe any of the mentioned items in the yard. No further action is required.

Complaint Investigation on 1/30/2017 at 14 Westbrook Lane

Health Inspector C. Whitehead stated that the complaint was regarding a pile of sheetrock and several TV's out at the curb and that haven't been picked up during weekly garbage collection. Secretary V. Galizia advised that building materials and televisions are not picked up by Waste Management. C. Whitehead did observe the mentioned items out at the curb and referred the complaint to the zoning inspector.

1. Update: 2017 Retail Food Establishment Licenses, Vending Machine Licenses & Pet Shop/Kennel Licenses: Valerie Galizia, Board of Health Secretary.

Secretary V. Galizia stated that all of the 2017 Retail Food Establishment Licenses, Vending Machine Licenses, and Pet Shop/Kennel Licenses have been paid.

NEW BUSINESS

1. Old McKeown House

Chairman D. Hansen stated that the old McKeown house on Route 519 burnt down a year ago and the only thing that has changed on it is that the top floor has been removed. He stated that something needs to be done to have the house taken down the rest of the way because it is a public health nuisance and a safety hazard if someone goes near it. He asked Health Inspector C. Whitehead to see if she can do anything to get the owner to move forward on taking the rest of the house down and report back at the next meeting.

2. March Meeting Discussion

Chairman D. Hansen suggested that the March 21, 2017 meeting be cancelled and all business be moved to the April 18, 2017 meeting. He also suggested meeting every other month from this point on.
