Safe Water Investigation on 1/24/2018 at Kittatinny High School

Health Inspector C. Whitehead stated that she did not do the water testing and that she will look into it and report back at the next meeting.

Safe Water Enforcement Action on 2/16/2018 at JCP&L

Health Inspector C. Whitehead stated that JCP&L failed to submit their Nitrate sampling for 2017. They were given a penalty for not submitting their lab results on time.

Safe Water Enforcement Action on 2/16/2018 at HMM Management

Health Inspector C. Whitehead stated that this was where the Hampton Deli was located. They should have still submitted a quarterly water sample and never did so they were issued a penalty.

Water Pollution Complaint Investigation on 2/21/2018 at 22 Lake Road

Health Inspector C. Whitehead stated that this property had laundry waste that vented to the front yard and was running down the street. The washing machine was hooked up to drain out on the front lawn. The owner will be connecting the washing machine to tie into the septic system. She will follow up and report back at the next meeting.

Rabies Cases on Various Dates

Health Inspector C. Whitehead stated that each case is assigned a number and that they come up multiple times on the report because each step needs to be documented. She stated that the first entry is usually the animal bite case being received, the second is the animal being quarantined for 30 days, and the third is correspondence on the animal being released from quarantine.
