CONSENT AGENDA ITEMS TO BE DISCUSSED SEPARATELY

Complaint Investigation at Hampton Convenience on 9/14/2018

Health Inspector C. Whitehead stated that this was a well inspection at the Hampton Mini Mall. She stated that each time the correspondence came through the office that it was documented in the Health Department reports but that everything was normal there.

Complaint Investigation at 9 Hemlock Woods on 10/30/2018

Health Inspector C. Whitehead stated that this was an anonymous complaint that came in to the Hampton Township Municipal Office stating that there was a massive pile of garbage on the edge of the road and bulky items on the property also. Health Inspector C. Whitehead went to investigate and did not observe any garbage at the edge of the road. She spoke with the complainant that said she spoke with the homeowner about the garbage and that they removed it.

A MOTION was made by T. Cassidy and seconded by E. Hayes, with all members in favor, to approve the items removed from the Consent Agenda.

OLD BUSINESS

1. PennJersey Environmental Consulting Portable Well Sampling Analytical Results

Chairman D. Hansen stated that he requested the portable well sampling analytical results for the Spartan Oil sampling site, also known as the Greatest Deals on Wheels. During the environmental investigation of the Site, elevated levels of benzene were detected in the groundwater. This contaminant belongs to a class of chemicals knows as volatile organic compounds (VOCs) and is often associated with gasoline or heating oil.

There was water testing done at the surrounding wells at the Hampton Diner, Dairy Queen, AAA Travel Agency/Sussex County Mattress. An access request letter was sent to the tenants of the Advanced Auto Parts store and two to the property owner but no response was received. The portable wells were sampled on July 19, 2018 and sent to TestAmerica of Edison for VOC analysis. The portable water samples did not exhibit any detected results for volatile organic compounds. These results indicate that the former Spartan Oil Company Hampton Terminal site groundwater plume has not impacted the groundwater quality outside of the Site, and no further actions are required regarding off-site wells relation to the former Spartan Oil Company Site remediation.

CORRESPONDENCE

1. State of New Jersey; Department of Environmental Protection- Plumbing Inspection Following Incident at McKeown Elementary School

A follow up letter was received at the Township regarding the incident that occurred at McKeown Elementary School in which the potable water supply became contaminated due to an old backflow prevention device failure at a cross connection of the school's interior plumbing system. The incident was handled and the system was flushed out.
