Chairman D. Hansen stated McDonalds did not have current Food Handler's Licenses. Secretary D. Juarez stated she reached to McDonald's as well as Dunkin Donuts, and they are both in the process of obtaining the Licenses.

Chairman D. Hansen asked Secretary D. Juarez to reach out again as a reminder that we need those certificates.

Secretary D. Juarez asked Chairman D. Hansen if Three Silos is seasonal as well. Chairman D. Hanses confirmed that they do operate seasonally and to The Townships and Board of Health's knowledge only sells prepacked beef.

Huber he is issuing a notice of violation for 12 Glenbrook Dr. Apparently, an addition was placed over the septic and the owner did not obtain a permit to do so. J. McDonough stated that was a problem because the lid to the septic tank was buried under the extension. J. McDonough stated there are no records of

when the addition was added anywhere. J. McDonough stated that the crawl space to get to the septic is very small and the septic companies do not want to fix it because if the individual going into that space passes out, there is no safe way to get them out of the confined space. Chairman D. Hansen stated they may have to abandon that tank and put a new one outside. J. McDonough said it is a possibility in this situation.

N. Walker asked about former Board of Health member, Peggy Bopp, who recently passed away. Chairman D. Hansen stated the viewing was today from 11:00 A.M. -1:00 P.M. at McCracken Funeral Home.

Chairman D. Hansen stated the Board of Health has 2 open vacancies and are in need of active volunteers.
