BE IT ORDAINED by the Township Committee of the Township of Hampton as follows:

SECTION 1. The annual salaries of certain officers, the hourly salary of certain employees and the compensation to be paid certain other employees of the Township of Hampton shall be and are set each year by Resolution in accordance with the salary ranges herein set forth.
