ORDINANCE NO. 2018-12 AN ORDINANCE TO AUTHORIZE THE ACQUISITION OF AN EASEMENT IN BLOCK 1403, LOT 7 IN ACCORDANCE WITH N.J.S.A 40A:12-1, ET SEQ.

- **WHEREAS** N.J.S.A. 40A:12-4 and 40A:12-5 authorize a municipality to acquire real property or any interest therein including easements;
- **WHEREAS** the Township of Hampton requires a drainage easement to be located on Block 1403, Lot 7;
- **WHEREAS** the owner of Block 1403, Lot 7 is willing to grant the Township a new 15-foot wide drainage easement from Lakeview Drive; and
- **WHEREAS** the governing body believes that the acquisition of the aforesaid easement is in the best interest of the municipality;
- **BE IT ORDAINED** by the Township Committee of the Township of Hampton, County of Sussex, State of New Jersey, as follows:
- **Section 1:** The governing body does hereby authorize the acquisition of a permanent 15-foot wide drainage easement on Block 1403, Lot 7 as depicted on Schedule A attached here and made a part hereof.
- **Section 2:** The Mayor and the Township Clerk are hereby authorized to execute any and all documents necessary for the acquisition of the easement which is the subject matter of this ordinance.
- **Section 3:** All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
- **Section 4:** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
- **Section 5:** A certified copy of this ordinance shall be forwarded to Kemah Lake Property Owners' Association, the owner of Block 1403, Lot 7.
- **Section 6:** This ordinance shall take effect after publication and passage according to law.
