## **HAMPTON TOWNSHIP ORDINANCE #2018-19**

AN ORDINANCE TO AMEND CHAPTER 76, ENTITLED "PARKS AND RECREATION AREAS", OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF HAMPTON, COUNTY OF SUSSEX, STATE OF NEW JERSEY

**BE IT ORDAINED** by the Township Committee of the Township of Hampton, County of Sussex, State of New Jersey, that Chapter 76 of the Revised General Ordinances of the Township of Hampton, entitled "Parks and Recreation Areas", shall be and is hereby amended as follows:

**SECTION 1.** Subparagraph (1) of Paragraph B of Section 76-2, entitled "Rules and regulations", is hereby amended to read as follows:

- (1) Having alcoholic beverages in one's possession unless and except as specifically and expressly permitted by Resolution adopted by the Hampton Township Committee in accordance with Section 33-20 of this Code.
- **SECTION 2.** If any provision of this Ordinance or the application thereof to any person or circumstances is held invalid, the remainder of this Ordinance shall not be affected thereby but shall remain in full force and effect.

**SECTION 3.** All ordinances or parts of ordinances inconsistent with or contrary to the provisions of this Ordinance are hereby repealed to the extent of such inconsistency or contrariness. All provisions of Chapter 76 not amended hereby shall remain in full force and effect.

**SECTION 4**. This Ordinance shall take effect immediately on its final passage and publication as required by law.
