

**HAMPTON TOWNSHIP  
ORDINANCE #2019-06**

**AN ORDINANCE APPROPRIATING THE SUM OF \$696,905.00 FOR IMPROVEMENTS TO ROADS AND DRAINAGE TO BE FUNDED IN PART WITH A GRANT RECEIVABLE FROM THE STATE OF NEW JERSEY DEPARTMENT OF TRANSPORTATION FUND IN THE AMOUNT OF \$164,000.00 AND WITH \$532,905.00 LOCATED IN THE GENERAL CAPITAL FUND ENTITLED "RESERVE FOR ROAD IMPROVEMENTS"**

**WHEREAS**, the Township of Hampton received a grant in the amount of \$164,000.00 from the State of New Jersey Department of Transportation for the purpose of improving Ridge Road; and

**WHEREAS**, it is deemed appropriate to make use of \$532,905.00 from the General Capital Reserves located within the General Capital Fund of the Township of Hampton for improvements to various roads and drainage projects within the Township of Hampton

**NOW, THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Hampton, Sussex County and the State of New Jersey that there shall be appropriated the sum of \$164,000.00 from a grant from the State of New Jersey, Department of Transportation and \$532,905.00 located within the General Capital Fund as stated above.

**SECTION 1.** There is hereby appropriated from the General Capital Fund the sum of \$164,000.00 for improvements to Ridge Road. Any funds received from private parties, the County of Sussex, the State of New Jersey or any of their agencies or any funds received from the United States of America or any of its agencies in aid of such purposes shall be applied to the payment of the cost of such purposes.

**SECTION 2.** There is hereby appropriated from the General Capital Fund the sum of \$532,905.00 for improvements to various roads and drainage projects within the Township of Hampton.

**SECTION 3.** All Ordinances or parts of Ordinances, which are inconsistent with the terms of this Ordinance, be and the same are hereby repealed to the extent of their inconsistency.

**SECTION 4.** This ordinance shall take effect immediately upon proper passage and publication in accordance with law.
