

HAMPTON TOWNSHIP ORDINANCE #2019-09

AN ORDINANCE TO AMEND CHAPTER 25, ENTITLED “RECREATION COMMITTEE”, OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF HAMPTON, COUNTY OF SUSSEX, STATE OF NEW JERSEY

BE IT ORDAINED by the Township Committee of the Township of Hampton, County of Sussex, State of New Jersey, that Chapter 25 of the Revised General Ordinances of the Township of Hampton, entitled “Recreation Committee”, shall be and is hereby amended as follows:

SECTION 1. Paragraph C of Section 25-3, entitled “Relation to Township”, is hereby amended to read as follows:

- C. The Township Committee shall annually appropriate in its budget funds an amount, in its discretion, that may be used for a balanced recreation program. If authorized by the Township Committee, the Recreation Committee may accept financial support from time to time from fees, gifts, donations or other sources.

SECTION 2. Paragraph D of Section 25-3, entitled “Relation to Township”, is hereby amended to read as follows:

- D. Neither the Recreation Committee, nor any member or members thereof, shall have any power or right, express or implied, to bind or obligate the Township of Hampton or the Township Committee of the Township of Hampton, directly or indirectly. No expenditures for recreation shall be incurred without approval by the Township Committee.

SECTION 3. Section 25-4, entitled “Duties”, is hereby amended to read as follows:

§ 25-4 Duties.

The primary purpose of the Recreation Committee shall be to initiate and to coordinate recreation programs and activities in the Township of Hampton.

SECTION 4. Section 25-5, entitled “Organization”, is hereby amended to read as follows:

§ 25-5 Organization.

The Recreation Committee shall hold a reorganization meeting each January during which it will elect a member as Chairperson and another member as Vice Chairperson to serve when the Chairperson is unavailable or unable to serve and will schedule its meeting dates for the year. The Township Committee shall select the Secretary for the Recreation Committee. If the Secretary shall be unable or unavailable to serve during a Recreation Committee meeting, the Chairperson shall select a person to serve as recording secretary *pro tempore*. Minutes of each meeting shall be prepared and provided to the Township Clerk for review by the Township Committee at its regular Committee meetings.

SECTION 5. If any provision of this Ordinance or the application thereof to any person or circumstances is held invalid, the remainder of this Ordinance shall not be affected thereby but shall remain in full force and effect.

SECTION 6. All ordinances or parts of ordinances inconsistent with or contrary to the provisions of this Ordinance are hereby repealed to the extent of such inconsistency or contrariness. All provisions of Chapter 25 not amended hereby shall remain in full force and effect.

SECTION 7. This Ordinance shall take effect immediately on its final passage and publication as required by law.
