ORDINANCE NO 2019-11 AN ORDINANCE TO AUTHORIZE THE ACQUISITION OF AN EASEMENT IN BLOCK 402, LOT 18 IN ACCORDANCE WITH N.J.S.A 40A:12-1, ET SEQ.

WHEREAS N.J.S.A. 40A:12-4 and 40A:12-5 authorize a municipality to acquire real property or any interest therein including easements;

WHEREAS the Township of Hampton requires a drainage easement to be located on Block 402, Lot 18, in the Township of Hampton, Sussex County, New Jersey;

WHEREAS the owner of Block 402, Lot 18 is willing to grant the Township a 10-foot wide drainage easement from East Shore Drive; and

WHEREAS the governing body believes that the acquisition of the aforesaid easement is in the best interest of the municipality;

BE IT ORDAINED by the Township Committee of the Township of Hampton, County of Sussex, State of New Jersey, as follows:

- **Section 1:** The governing body does hereby authorize the acquisition of a permanent 10-foot wide drainage easement on and across Block 402, Lot 18 as described more particularly in metes and bounds description prepared by Gary L. Worley, PLS in conjunction with Hampton Township Planning Board Application #19-08PB and containing 0.026 +/- acres of land.
- **Section 2:** The Mayor and the Township Clerk are hereby authorized to execute any and all documents necessary for the acquisition of the easement which is the subject matter of this ordinance.
 - **Section 3:** All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
- **Section 4:** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
- **Section 5:** A certified copy of this ordinance shall be forwarded to Albert John Johansson and Diane M. Johansson, the owners of Block 402, Lot 18.
 - Section 6: This ordinance shall take effect after publication and passage according to law.
