

**HAMPTON TOWNSHIP  
ORDINANCE #2020-08**

**AN ORDINANCE APPROPRIATING THE SUM OF \$241,000.00 FOR THE PURCHASE OF A 2021 CHASSIS AND AERIAL LIFT FORESTRY BODY TO BE FUNDED WITH \$200,000.00 LOCATED IN THE GENERAL CAPITAL FUND ENTITLED "RESERVE FOR ROAD EQUIPMENT" AND \$41,000.00 LOCATED IN THE CAPITAL IMPROVEMENT FUND**

**WHEREAS**, it is deemed appropriate to make use of \$200,000.00 from the General Capital Reserves located within the General Capital Fund of the Township of Hampton for Purchase of Road Equipment;

**WHEREAS**, it is deemed appropriate to make use of \$41,000.00 from the Capital Improvement Fund;

**NOW, THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Hampton, Sussex County and the State of New Jersey that there shall be appropriated the sum of \$200,000.00 located within the General Capital Fund and \$41,000.00 located within the Capital Improvement Fund for the purchase of a 2021 Chassis and Aerial Lift Forestry Body.

**SECTION 1.** There is hereby appropriated from the General Capital Fund the sum of \$200,000.00 for Purchase of Road Equipment.

**SECTION 2.** There is hereby appropriated from the Capital Improvement Fund the sum of \$41,000.00.

**SECTION 3.** All Ordinances or parts of Ordinances, which are inconsistent with the terms of this Ordinance, be and the same are hereby repealed to the extent of their inconsistency.

**SECTION 4.** This ordinance shall take effect immediately upon proper passage and publication in accordance with law.
