HAMPTON TOWNSHIP ORDINANCE #2021-10

AN ORDINANCE TO AMEND PARAGRAPH B OF SECTION 61-8, ENTITLED "PERMITS AND CERTIFICATE OF FIRE CODE STATUS", OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF HAMPTON, COUNTY OF SUSSEX, STATE OF NEW JERSEY.

BE IT ORDAINED, by the Township of Hampton, in the County of Sussex, New Jersey, as follows:

SECTION 1. Paragraph B of Section 61-8, entitled "Permits and Certificate of Fire Code Status" of the Revised General Ordinances of the Township of Hampton, County of Sussex, State of New Jersey, is hereby amended to read as follows:

B. The fee for the issuance of a certificate of smoke alarm, carbon monoxide alarm, and portable fire extinguisher compliance (CSACMAPFEC) pursuant to N.J.A.C. 5:70-2.3 shall be \$50. If the property shall fail to comply on initial inspection, the fee for reinspection shall be \$40 for each reinspection needed to issue the certificate. The property owner is responsible for applying for each reinspection.

SECTION 2. If any provision of this Ordinance or the application thereof to any person or circumstances is held invalid, the remainder of this Ordinance shall not be affected thereby but shall remain in full force and effect.

SECTION 3. All ordinances or parts of ordinances inconsistent with or contrary to the provisions of this Ordinance are hereby repealed to the extent of such inconsistency or contrariness.

SECTION 4. This Ordinance shall take effect upon final passage and publication in accordance with the laws of the State of New Jersey following the required twenty-day period after adoption, as set forth in N.J.S.A. 40:69A-181(b).
