HAMPTON TOWNSHIP ORDINANCE NO. 2023-20

AN ORDINANCE TO AMEND SECTION 76-2, OF CHAPTER 76 ENTITLED "PARKS AND RECREATION AREAS" OF THE CODE OF THE TOWNSHIP OF HAMPTON, COUNTY OF SUSSEX, STATE OF NEW JERSEY.

BE IT ORDAINED by the Township Committee of the Township of Hampton in the County of Sussex, as follows:

SECTION 1. Subparagraph (2) of Paragraph (A) of Section 76-2, entitled "Rules and regulations" of Chapter 76, entitled "Parks and recreation areas" of the Code of the Township of Hampton is amended to read as follows:

(2) Fail to cooperate in cooperate in maintaining rest rooms and washrooms in a neat and sanitary condition.

SECTION 2. Paragraph B of Section 76-2 entitled "Rules and regulations" of Chapter 76, entitled "Parks and recreation areas" of the Code of the Township of Hampton is amended to add Subparagraph 15 which shall read as follows:

(15) Feed, in any public park or on any other property owned or operated by Hampton Township, any wildlife. For the purpose of this subparagraph, "feed" shall mean to give, place, expose, deposit, distribute or scatter any edible material with the intention of feeding, attracting or enticing wildlife. For the purpose of this subparagraph, "wildlife" shall mean all animals that are neither human nor domesticated and excludes confined wildlife (for example, wildlife confined in zoos, parks or rehabilitation centers, or unconfined wildlife at environmental education centers, or feral cats as part of an approved Trap-Neuter-Release program). Excepted from the requirements of this subparagraph is baiting in the legal taking of fish and/or game.

SECTION 3. Paragraph A of Section 76-4 entitled "Enforcement of rules and regulations; when effective" of Chapter 76, entitled "Parks and recreation areas" of the Code of the Township of Hampton is amended to read as follows:

A. The Code Enforcement Officer and/or his/her designees or any law enforcement officer is/are authorized to enforce the provisions of this chapter.

SECTION 4. All Ordinances or parts of Ordinances inconsistent herewith are repealed as to such inconsistencies.

SECTION 5. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

SECTION 6. This Ordinance shall take effect upon its passage and publication as provided by law.
