RESOLUTION TO CANCEL PARTIAL 2024 TAXES DUE TO QUALIFIED 100% DISABLED VETERANS' EXEMPTION

WHEREAS, Mr. Samuel Nazzaro, is the owner/resident of Block 1801.01 Lot 4.04, also known as 74 Mary Jones Rd; and

WHEREAS, Mr. Nazzaro has filed for 100% Veterans deduction for the year 2024; and

WHEREAS, Mr. Nazzaro has been awarded 100% Disability by the U.S. Department of Veterans Affairs; and

WHEREAS, Mr. Nazzaro has met all the requirements of the State of New Jersey for the 100% disability exemption for a Veteran; and

WHEREAS, Mr. Joseph Ferraris, Tax Assessor, has approved Mr. Nazzaro's Veteran Exemption for his property; and

WHEREAS, Mrs. Leah C. Korver, Tax Collector, requests that \$3,747.37 from the first 2 quarters of the 2024 taxes be canceled due to Mr. Nazzaro's qualified exemption on the property; and

WHEREAS, Mr. Nazzaro's 1st quarter taxes were paid in full in the amount of \$1,873.69 by the mortgage company on February 2, 2024; and

WHEREAS, the Tax Collector is requesting to refund Mr. Nazzaro's tax payment for a refund of \$1,873.69.

NOW THEREFORE be resolved by the Hampton Township Committee of the Township of Hampton, Sussex County, State of New Jersey that approval be granted to cancel first half 2024 taxes in the amount of \$3,747.38 for Block 1801.01 Lot 4.04, and

BE IT FURTHER RESOLVED, a refund be issued for taxes already paid in the amount of \$1,873.69.
